Introduction

The Ohio State Chiropractic Board is a state government agency that was established by the legislature in 1975 to regulate the practice of chiropractic and to protect the health, safety and welfare of the public. The Board is responsible for examining and licensing chiropractic physicians and enforcing the provisions of Chapter 4734 of the Ohio Revised Code (ORC) and the Administrative Code (OAC) adopted by the Board.

The Board is entirely self-sustaining through revenue generated from fees collected for license applications, license renewals, fines, and miscellaneous services.

The Ohio Attorney General is the statutory legal counsel to the Board. An Assistant Attorney General from the Health and Human Services Section represents the Board in administrative hearings and court proceedings.

Mission Statement

Our mission is to proactively protect the health and welfare of Ohio's citizens and to regulate the chiropractic profession with vision by setting high standards for licensure and by fairly and consistently enforcing those standards through examination of new doctors, annual license renewal, clinic inspections, and timely investigation and disciplinary action when indicated.



Board Staff

The Board employs six full time employees to carry out its duties and responsibilities. The regular working hours of the Board are Monday through Friday, 8:00 a.m. to 4:30 p.m., excluding state holidays.

Kelly A. Caudill, Executive Director

Ms. Caudill serves as the chief enforcement officer for the Board, enforcing the laws and rules governing the practice of chiropractic in Ohio. Ms. Caudill also directs and manages all activities and programs of the Board office, carries out the Board Members' directives, and oversees all legal and legislative activities.

Elizabeth N. Moore, Administrative Assistant

Liz functions as the Board's office manager and is responsible for the administration of clerical support, personnel, training, telecommunications, fiscal, travel, payroll and employee benefits. Liz also serves as liaison to the Board members for their administrative support needs.

Laurie A. Allison, Licensing Coordinator

Laurie handles initial licensing, examinations, annual license renewal and continuing education. She acts as the front desk receptionist and provides support to the Board and staff.

M. Kate Borloglou, Paralegal

Kate joined the staff in November of 2007 and is responsible for gathering preliminary case information and researching data to support the legal and enforcement staff, processing public records requests, conducting basic investigations and monitoring doctors subject to discipline and Quality Intervention participants.

Rex J. Waldenmyer, Investigator

Rex and T.J. conduct investigations relative to complaints involving the practice of chiropractic. These investigations may be highly specialized, complex and long-term. Investigations of persons rendering chiropractic services are conducted to determine the facts in each case, ascertain the exact basis of the complaint, and confirm allegations for administrative, civil, and criminal actions.

Chiropractic Board Members & Terms of Office

The Board is comprised of four chiropractic physicians and one public member. The Governor, with the advice and consent of the Senate, appoints the members to four-year terms. Members are eligible to be re-appointed once. Board members are compensated hourly for actual time devoted to the Board's affairs, and are reimbursed for expenses incurred in the performance of their official duties.

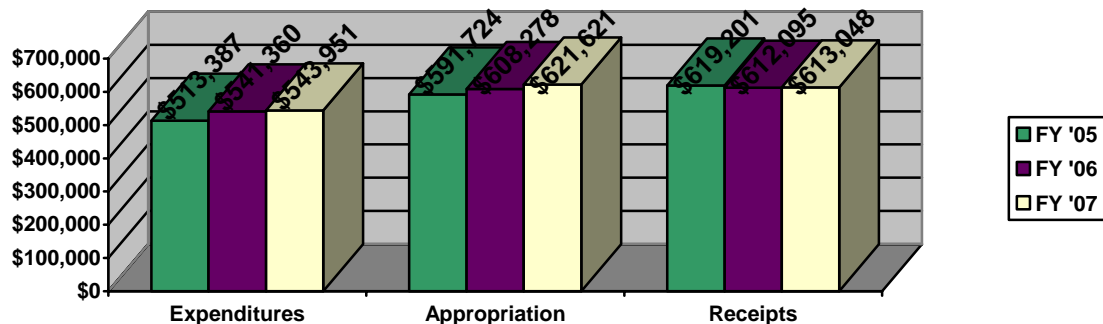

Examination Activity

The Board requires all applicants for licensure to successfully take and pass a Jurisprudence examination. The Board holds four exams per year. This is a one-day examination that is proctored by the Board staff. During the Jurisprudence Examination Orientation each of the Board members give a brief speech to the licensees prior to the examination. Once the examinations are graded, the Board members present each passing applicant with their exam score and license number. The Board also administers an oath to the applicants as a group.

Enforcement Statistics

The Executive Director serves as the Chief Enforcement Officer and enforces the laws and rules governing the practice of chiropractic. All complaints are reviewed to determine preliminary disposition: closure, referral to another agency, full field investigation, or hold open pending further information. Random compliance inspections are conducted by Board Investigators to ensure compliance with the Board's laws and rules. The Board regularly works with law enforcement agencies

statewide to investigate and prosecute misconduct by chiropractic physicians and the unlicensed practice of chiropractic.

Dr. Burda made up the term “Bahlaqem” to describe a form of treatment that he developed in which he claimed to treat individuals anytime, anywhere, who were not in his presence and without physical contact.

The Board determined that “Bahlaqem” is not an acceptable form of treatment according to acceptable and prevailing standards of chiropractic care and constitutes practicing beyond the scope of practice of chiropractic. The Board also determined that Dr. Burda was also unable to practice according to acceptable and prevailing standards of care due to mental illness.

Dr. Burda signed a Voluntary Permanent Surrender of License to Practice Chiropractic in the State of Ohio, thereby permanently revoking his license.

On certain dates from on or about January 1, 2004 to February 22, 2004 Dr. Fick practiced chiropractic in the state of Ohio without a current, valid license from the Ohio State Chiropractic Board. Dr. Fick failed to attend a Board approved license renewal seminar as required for 2004 renewal.

Dr. Fick entered into a Consent Agreement with the Board wherein he received a 2 week Suspension, 18 months Probation, a \$1000 civil fine and additional probationary stipulations.

Richard K. Owen, D.C.

Violated Codes and/or Rules: Ohio Revised Code § 4734.31 (C)(1)

The Board refused Dr. Owen's application for reinstatement of his chiropractic license filed with the Board on April 5, 2006 due to the fact that on or about December 15, 2000, in the Court of Common Pleas, Medina County, Ohio, Case Numbers 00-CR-0062 (Patient A) and 00-CR-0214 (Patient B), Dr. Owen was found guilty of two counts of Gross Sexual Imposition, felonies of the fourth degree. Dr. Owen also engaged in inappropriate sexual contact with a third patient (Patient C).

The Board denied Dr. Owen's application for reinstatement on the basis that he does not possess the proficiency or competency, character and fitness to practice chiropractic in the state of Ohio.

Quality Intervention Program

During fiscal year 2006 the Board implemented its Quality Improvement Program (QIP), in accordance with Ohio Revised Code Section 4734.42.

The QIP is a *confidential* alternative to formal disciplinary proceedings. The mission of the QIP is to effectively address licensees with quality of care and communication issues that may have developed due to poor practice patterns or failure to keep up with current standards of practice. The QIP is under the umbrella of the Board's investigatory process and for this reason participation in the QIP is confidential and not subject to discovery in any civil proceeding.

If QIP intervention is successful, the licensee will benefit by improving his or her practice patterns, thus providing valuable chiropractic care to his or her patients; the patients and community will benefit by having a better practitioner available to address their needs; the Board will have protected the public without having an adverse impact on the availability of chiropractic care.

During FY 2007 seven licensees were invited to participate in the QIP, of whom five accepted the invitation. Each licensee was invited due to poor documentation and recordkeeping, with one licensee also invited for boundary issues. All five chiropractic physicians successfully completed the QIP.
